Be it ordained by the City Council of the City of Beverly as follows:

By amending Chapter 282, Section 282-13, subsection C entitled "Demand charge" of the 2016 Beverly Code of Ordinances by inserting the following schedule of charges in subsection C, after the last sentence of that subsection:
