No in-person attendance of members of the public will be available, but every effort will be made to ensure that the public can adequately access the proceedings in real time, via technological means. In the event that we are unable to do so, despite best efforts, we will post on the City's website an audio or video recording, transcript, or other comprehensive record of proceedings as soon as possible after the meeting. **Please see below for detail on accessing the meeting remotely.**

      3. Then click ‘Enter a meeting code’ and type in ‘[wwi-rbhi-hmi](https://meet.google.com/wwi-rbhi-hmi)’. Then click ‘Ask to join.’ A facilitator will enable you to enter the meeting.
  - b. **Telephone: For standard telephones and cell phones:**

    2. When prompted, enter the PIN: [777 849 906#](https://www.beverlyma.gov). A facilitator will enable you to enter the meeting.
