 2. Allow the program to access your device's camera and microphone.
 3. Then click 'Enter a meeting code' and type on 'iwo-rium-zcp.' Then click 'Ask to join.' A facilitator will enable you to enter the meeting.
 - b. **Telephone: For standard telephones and cell phones:**
 1. Dial the number 1-567-275-2720.
 2. When prompted, enter the PIN: 728-216-885#. A facilitator will enable you to enter the meeting.
